

The Grid Esports Giveaway Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Giveaway is open only to those who are at least 18 years of age and who reside in the United States of America.

2. Agreement to Rules: By participating, the Contestant (“You”) agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of The GRID Esports as final and binding as it relates to the content of this Giveaway.

3. Giveaway Period: Entries will be accepted starting Monday, September 21, 2020 at noon and ending October 1, 2020 at noon. All online entries must be received by October 1, 2020 at noon.

4. How to Enter: The Giveaway must be entered by commenting on the specified social media posts. The entry must fulfill all Giveaway requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of The GRID Esports.

The specifics of the prize shall be solely determined by The GRID Esports. No cash or other prize substitution shall be permitted except at The GRID Esports discretion. The prize is nontransferable.
